CALL FOR NOMINATIONS: UPCOMING EXECUTIVE COMMITTEE ELECTIONS

Dear Alumni,

We are pleased to announce the opening of nominations for the upcoming Executive Committee elections of KVHAA. As part of our democratic process, we invite you to nominate yourself or fellow eligible members for the various positions on the Executive Committee.

Positions Open for Election:

- **President** 1 position
- **Vice President** 1 position
- **Secretary** 1 position
- **Joint Secretary** 1 position
- **Treasurer** 1 position
- **EC Members** 5 positions

Please review the eligibility criteria and election process outlined below.

Eligibility to Stand for Election

1. Only ratified members with voting rights, as per the existing rules, are eligible to stand for election.
2. To contest any position, a member's name must appear on the electoral rolls published by the Electoral Officer(s) appointed by the Executive Committee.

Voting Guidelines

1. Each member is entitled to cast one vote.
2. In the event of a tie for any position, the decision will be made by a draw of lots.
3. Members must vote in person at the designated venue or through approved virtual methods. Proxy voting is not permitted. Further details on voting methods will be shared in subsequent communications.

Nomination Guidelines

1. Each nomination must be proposed and seconded by two different ratified members of the Association.
2. The nomination must include the candidate's written consent via email and a signed declaration in the nomination form.
3. The Election Committee will scrutinize all nominations. Rejected nominations will be communicated to candidates with reasons provided within a specified timeline. The decision of the Election Committee is final in this regard.
4. Nomination forms (attached here) must be signed, scanned, and submitted via email to election.convener.kvhaa@gmail.com. If the proposer and seconder are in different locations, their forms may be sent separately and combined with the candidate's form for validation.
5. After the withdrawal deadline, the Election Committee will publish the final list of valid nominations to all members and candidates.

Election Outcomes

1. If a position has only one nominee, the Election Committee will declare the candidate elected unopposed.
2. For contested positions, elections will be decided by a secret ballot, with the candidate receiving the highest number of votes elected to the respective position.

We encourage all eligible members to participate in the nomination process and be part of shaping the future of our alumni community.
