Proceedings

1. The EC meeting was called to order by the Secretary, KVHAA at 2100 Hrs. 08 EC members and one Patron participated in the meeting, attendance sheet is placed at Annexure 1. The Secretary warmly welcomed the participants of the meeting.

2. **Ratification of Newly Registered Members of KVHAA**. The Secretary submitted that as of 31 Mar 2025, a total of 56 new alumni have registered with the KVHAA. As per the extant procedures under KVHAA Rules & Regulations, the membership applications of the 56 alumni were scrutinised by the EC. 50 memberships were approved and ratified and 06 are pending view some clarifications. Welcome/ confirmation emails shall be forwarded to the new registrants shortly.

3. **KVHAA Website Domain Expiry Issue**. The Secretary brought out that the domain subscription of the KVHAA website <https://kvhalumni.com> with GoDaddy and the server subscription have expired and the same need to be renewed. The EC unanimously decided and authorised the following: -

- (a) Renew the domain subscription for a period of two years at an expenditure of Rs. 3,575/- towards the subscription fee for two years.

(b) Renew the server subscription for a period of one year at an expenditure of Rs. 3,500/- towards the subscription fee for one year.

4. **Monetising KVHAA website.** The Secretary submitted to the EC that some alumni who are business owners had requested that the KVHAA website may be utilised to advertise their businesses online on the basis of a nominal subscription fee or any payment model, as decided by the EC. The EC had a preliminary discussion on the issue and decided that this issue requires detailed deliberations.

5. **Enhancement of Lifetime Membership Fee.** Vide the Minutes of the EC meeting held on 17 Feb 2025, the EC had unanimously decided that the Lifetime membership fee be enhanced from the current Rs. 600/- to Rs.1,000/- with effect from 01 Apr 2025. Based on numerous appeals from many alumni to extend the deadline for the lifetime membership fee hike, the EC unanimously decided to provide a one-time extension for the deadline upto midnight of 15 Apr 2025.

5. **Alumni Database Update.** The Secretary brought out that as on date there are around 470 registered members in the KVHAA database. Scrutiny of the current alumni database has indicated numerous inconsistencies in the data viz. wrong email IDs, incomplete mobile numbers, duplication, etc. The EC decided to form a Special Task Force comprising EC members and some alumni volunteers by 15 Apr 2025 to undertake the crucial task of Alumni database updation.

6. **Finalisation of Mentors & Co-chairs for SIGs.** The list of newly appointed Mentors and Co-chairs for some of the SIGs is placed at Annexure 2.

7. **Status of Accounts Handing Over/ Taking Over.** The Treasurer submitted to the EC that the process of accounts handing over/ taking over shall be completed by 15 Apr 2025. The Treasurer also proposed to shift the current branch of the Bank of Baroda (Chola Nagar) to Malleshwaram branch. EC approved of the proposal.
